SUBJECT: Website Re-design 2023 – New Town Logo

Wendy and Kim have been working on a free re-design of the Town's website with Civic Plus. Early on, Civic Plus brought to their attention that they would not be able to use the Town's logo due to the low resolution. We also had trouble with other companies telling us the same when it came to using our Town logo and seal (Galen needed for Sesquicentennial and Music in the Park). Wendy and Kim then told me what was going on and they talked about the logo, and we came to a consensus that perhaps the logo needed to be freshened up. We left the meeting with them trying to figure out where to go from there.

Councilmember Pent had talked to me at one of our weekly meetings about the Town's website and mentioned to me that he would be happy to volunteer his time with the website as he had expertise in this. I passed this onto Wendy and Kim, and they met with him outlining the logo resolution issue and the fact that they felt the logo could use a facelift. They also discussed new pictures for the website, of which Councilmember Pent volunteered his son to take pictures (including a night shot) with the drone.

In looking at the logo and giving it a facelift the attached is suggested. This represents the history of the Town as well as its importance with the Constitution. It maintains the Courthouse, of which the Town is a Courthouse Town, the Blue Ridge mountains are in the background, and we added the words Town of. The main question would be should we represent a historical town (tourism) or a bedroom community with steady progress? We realize that the current logo was created under Ray Lonick, and we do not wish to take anything away from his legacy, thereby maintaining the courthouse, Blue Ridge mountains, and the implied sunset with the orange background.

We are excited about the new logo, but also understand the value of our longstanding current one. We need to get your thoughts as soon as possible regarding the new logo, as Wendy and Kim have website re-design deadlines to meet.

Dear Mr. Woods:

Just to reiterate, we asked the Orange Town Council to consider an additional \$15,000 to support the Clinic's mental health services that is underfunded at this time. We are actively seeking additional funding to sustain this critical position into the next fiscal year. Our recent Hope Blooms Gala was dedicated to keeping our mental health services funded and we are committed to keeping this service available to patients at the OCFC.

Orange County Free Clinic (OCFC) is the only full time safety net for the County and for residents in the Town of Orange. Currently the Clinic has 2,031active patients with 41% living in the Town of Orange (over 830 patients). We recognize the importance of access to quality healthcare especially in rural communities, and the OCFC provides that and more.

As mentioned, the OCFC is helping to fill the gap in mental health services with our part-time mental health counselor, who by the way, is already seeing the great need as her patient load is filled to capacity. We might mention that when we were seeking a counselor to fill the position, we called several mental health providers, and the RRCSB, and they too are unable to meet demand from residents seeking mental health care in our community. As Mr. Sherman mentioned "the Clinic's counseling services are at least a start"!

I would ask that you refer to our FY24 request letter submitted in December for additional information on all of the Clinic's programs and services. We always welcome visits and appreciate every opportunity to provide a "tour" to further emphasize our role in keeping our community strong and healthy.
